- First Match Consolation. Consolation eligibility for players defaulting first round matches will be at the discretion of the Tournament Committee.

- Players may list only one conflict in either singles or doubles. The conflict will be considered by the Tournament Committee. There is no guarantee that the conflict can be accommodated.
- The *Buddy Dey Memorial Trophy* will be presented to the Men's Open Singles Champion. The *Mabel Kivlighan Memorial Trophy* will be presented to the Women's Open Singles Champion. The *Frank R. Pancake Memorial Trophy* will be presented to the person that accumulates the most points in the adult open divisions (excluding consolation round play).
